During its meeting of 18 March, the Commission reviewed the concept design for the proposed new lighting scheme for the Lincoln Memorial. Based on the previous evening's demonstration of the new scheme, the members found the revised illumination to be a great improvement over the existing system. There were several recommendations made to fine tune the lighting levels to create a more even illumination of the entablature above the entrance colonnade, to lower the over-all brightness of the light on the sculpture of Lincoln, and to reduce the direct light on the flanking walls behind the sculpture.

With these adjustments, the Commission approved the concept submission and requests that the final plans be forwarded to the staff for our delegated final approval.

During its meeting of 18 March, the Commission reviewed the joint submission from the Kennedy Center and the Federal Highway Administration for the revised concept design for the Kennedy Center's new plaza and expansion project, and the new roadway configuration for the portion of Interstate 66 that surrounds and isolates the Center from the city. Once again, the design by Architect Rafael Viñoly was found to be well thought out and thorough in scope. The revisions to the plan that have developed since it was presented last year have improved the project in many significant ways. The new opening in the extended terrace projecting over the river blank on the west side of the Center is very welcome in that it will prevent a tunnel-like feeling for those driving on the Rock Creek and Potomac Parkway under the cantilevered west terrace. The changes to the east side terrace and plaza deck have only strengthened the concept and have addressed many functional needs as well as improving access. The modifications to the two buildings flanking the east terrace are also seen as improvements.

The reconfiguration of the highways, access roadways, and the new pedestrian paths and bicycle trails, as proposed by the Federal Highway Administration, will undoubtedly improve the ease of access for the Center's patrons and visitors, as well as for the general public traveling through the vicinity of the Center. We understand that there is much more work to be done on the design of the roads, bridges, and pathways, and the members hope that there is additional thought given to the pedestrian access from the north. Currently it is, and may well stay, the primary route in the future for those arriving on foot as it is the most direct path to the nearest Metro station. Every effort should be taken to make this approach as welcoming and inviting as possible and to avoid having a patron feel as though they arrived at the Center's "side door."

All together, the joint submission for the revised concept for the plaza and expansion, and for the proposed reconfiguration of the roadways, was unanimously approved by the Commission.

The members look forward to the continuing review of the project and to working with you, your design team and the Federal Highway Administration's team throughout the project. As always, the staff is available should there be questions.

During its meeting of 18 March, the Commission reviewed and approved the proposed concept for facade alterations for a new chancery for the State of Qatar at 2555 M Street, NW (S.L. 04-042). The design is greatly improved since the additions have been more strongly integrated with the existing structure. As the project moves forward, the design of the canopies requires additional development as they appear rather diminutive in comparison with the bold entrance and stair tower. In addition, careful consideration of material for the horizontal banding through the glass addition will be important when detailing the front facade.

During its meeting of 18 March, the Commission reviewed the final plans for the perimeter security barriers, guard booths and landscape alterations for the Eccles and Martin buildings. The members approved the plans for both buildings with the exception of the design of the small guard booths to be located on the north side of the Martin building. It was felt that the materials used to sheath these booths should not be the same as the existing garage entry pavilion and that perhaps the design should be more complementary to the materials of the Martin building.

The Commission has in the recent past reviewed several guard booth designs that may be useful to study in developing an alternate design. The members asked that you and the design team work with our staff as a new design is developed. The alternative design can be submitted to the staff for the Commission's delegated final approval. During its meeting of 18 March, the Commission reviewed and approved the revised concept for additions and renovations to the District of Columbia Old Courthouse, on Judiciary Square between D and E Streets. Although the Commission felt that the design was respectful of the existing structure with regard to height and width, a decrease in the depth of the addition should be investigated in an effort to provide a larger landing between the stairs and new entrance. The design for the open space north of the entrance stairs, including the proposed slope of 3.7 percent, is reasonable and acceptable. A large-scale model of the entrance pavilion with its surrounding spaces should be submitted with the next submission, to help determine the appropriate configuration of the pavilion and its relationship to the plaza.

The Commission looks forward to further review of this project in the near future.

During its meeting of 18 March 2004, the Commission reviewed the final design for the proposed perimeter security fence along the Anacostia River waterfront at the Washington Navy Yard. We appreciate the opportunity given us to visit the Washington Navy Yard on the morning of 19 February.

As the length of the fence is daunting, the brick piers and pedestrian entrances do not offer not enough variety to reduce the visual impact and hold the design together. The members suggested that removing the brick piers would improve the appearance of the fence since the piers were not well designed. A simpler metal fence without piers, but with additional landscaping, would be preferable.

The members were disappointed that previous recommendations to consider larger open spaces had not been explored. If properly designed, these open spaces would not diminish security needs or potential use of the space by the Navy Yard, and they would greatly benefit the pedestrian experience of the waterfront. Because these recommendations were not considered, the final design did not receive an enthusiastic reception. With these recommendations the design was approved with reservations.

The Commission looks forward to review of additional installations throughout the capital city at an early stage of design to consider the options available to the Navy to meet security requirements.

During its meeting of 18 March 2004, the Commission reviewed the proposed temporary modular building for the Smithsonian Early Enrichment Center (SEEC) to be located on the grounds at the east end of the National Museum of American History. Understanding that the SEEC will eventually be relocated in the National Museum of Natural History, the installation of the temporary modular building was approved with reservations.

The chosen site offers the advantage of a drop in level to screen views of the concrete building from the Mall. Additional landscaping will help screen it at ground level. However, the members felt its design to be rather harsh. They expressed concern about the impact on the children who will use this facility for the next three to five years. On that note, five years may be too long for a temporary structure. The Commission prefers that the life of the building be moved closer to the three year deadline.

During its meeting of 18 March, the Commission reviewed the final plans for the new Ward 4, Old Kennedy Theatre Senior Wellness Center, 318-324 Kennedy Street, NW, for the District of Columbia's Office of Aging. The members requested three changes be made in selection of materials for the building. The sample of yellow-bronze metal that was proposed for the window frames was thought to be too bright in color and not in keeping with the historic character of the existing buildings. The color of the window frames should match the darker bronze-colored metal trim used elsewhere on the building. For the window glass, the members recommended the use of clear glass instead of the darkly tinted glass presented.

Clear glass would permit more light to enter the building and allow the building to appear more lively from the street. The third change requested was for the new rear walls of the building not to be sheathed in the light-colored split-faced masonry units presented. Brick should be used instead so that the new walls better complement the preserved brick walls of the historic buildings.

The staff will be able to review the revised drawings that reflect these requested changes and with the submission of the revised drawings, the project can be considered approved.

Once again, the members expressed appreciation for the efforts of the Office of Aging to bring life back into these structures and acknowledged that this project will provide a welcome amenity for the senior members of the Ward 4 community. Please let us know if you have any questions.
